The listed ten stressful events for children of divorce are in no way gender specific. The blatant Dad bashing is unconscionable and indefensible. Can you imagine a young person seeing this poster when in fact their family situation involves a mother asking questions about the Dad, a mother saying bad things about the Dad, the mother saying she doesn't like the child spending time with their Dad, and the mother acting unhappy?

We respectfully ask that the poster and all similar gender discriminatory posters, flyers, brochures, and other such items be immediately removed from all San Diego Superior Court Houses.
