According to numerous news reports Wayne County Circuit Judge Wade McCree Jr.:

- (1) Impregnated Geniene La'Shay Mott who was a plaintiff in a child-support case before him, and allowed her to help choose the sentence he would impose on her ex-husband.
- (2) That Mott and McCree often had sex in his chambers.
- (3) That Mott and McCree plotted to impose a sentence on Mott's ex-husband for failing to pay child support.

Clearly Judge McCree's actions noted above, if true, do not serve to promote the integrity of the judicial process or preserve public confidence in the courts.

We surmise such misconduct is contrary to and a violation of the Code of Judicial Conduct and Rules of Professional Conduct published with the Michigan Rules of Court and elsewhere, as applicable.

Such misconduct is inexcusable. If true, we ask that Judge McCree be disbarred or otherwise suffer the most serious sanctions available to the Judicial Tenure Committee.

As an aside, courts nationwide suffer from a poor reputation when it comes to fathers and child support. Though surely an isolated situation, Judge McCree does nothing to dispel that fact.
