**To the Foreperson of the Los Angeles County Grand Jury,**

A **Voice for Men** has received your letter dated May 7, 2013 regarding our notification of a serious public corruption issue that is occurring within the City and County of Los Angeles. The documents provided, consisting of a 250 page complaint along with over 50 attachments, exhibits, audio and video files, and photographs in excess of 1,500 pages of detailed information, will justify the necessity for a formal Grand Jury investigation, and for additional actions to prevent the compromise of this inquiry, and to prevent retaliatory actions, evidence destruction and witness intimidation.

As our first letter indicated, this complaint involves multiple acts of public corruption; violations of civil rights, and multiple violations of federal and state laws surrounding the abuse and criminal exploitation of the restraining order system in Los Angeles County. The information provided will reveal one of the most egregious abuses of the restraining order process in the history of the State of California. A partial list of federal crimes include; Civil Rights Violations, Deprivations of Rights under Color of Law, and Honest Services Fraud. A partial list of state violations include; Perjury, Conspiracy, Fraud, Battery, Obstruction of Justice, and quite possibly; Homicide. The primary individuals responsible for these crimes include;
