Committed to ending harmful gender based stereotypes

NCFM is troubled the City of San Diego and County Sheriff's Department are using public resources to actively support and participate in the San Diego Military Women (No-Men-Allowed) Careers Event on Friday, September 14, 2018. Such involvement violates the Equal Protection Clauses of the California and U.S. Constitutions. Both of which clearly prohibit the City and County from discriminating against men or women.

In the attached September 5, 2018, email, from the City of San Diego's Darisha Hunter, the City boldly promotes the so-called "San Diego Military Women Careers Event." The email asserts, "We are hosting our Women's Military Career Fair on 9/14/18," and extends an invitation to the Military Women's Resource Center Career Fair catering to Women's Veterans, Active Duty Females, and Spouses [and] THIS EVENT IS ALSO OPEN TO WOMEN IN THE GENERAL PUBLIC."

Inconceivably, the City and the County of San Diego appear little concerned with similarly situated Male Veterans, Active Duty Males, Male Spouses, and MEN IN THE GENERAL PUBLIC despite the hugely disproportionate sacrifice these brave men have made.

As of April 1, 2017, 2,296 of the 2,346 U.S. Military members who lost their lives in Operation Enduring Freedom were men. A similarly grossly disproportionate number of "Male Veterans" and "Active Duty Males" suffered injuries in Operation Enduring Freedom. Many of these debilitating injuries, such as lost limbs, are borne by these male veterans for the rest of their lives, including while looking for a job to support their families.

To be clear, California government entities are prohibited from discriminating against persons based on their sex by the equal protection clauses of the U.S. Constitution and the California Constitution (specifically Art. I, § 31 (Proposition 209); Art. I, § 7, subd. (a) and Art. IV, § 16 subd. (a)) of the latter, as well as California Government Code section 11135. Moreover, the City of San Diego Human Rights Commission intakes, investigates and resolves citizen sex-discrimination complaints.

Thus, the San Diego Military Women Careers Event is immoral and illegal. One would think our elected officials and law enforcement agencies would be protectors of the law, diversity, and inclusion, as well as our entire military. Instead, they shamefully offer a politically correct if not expedient substitute, which openly disrespects over 95% or our past and present military personnel, males.

NCFM is very familiar with the Equal Protection Clauses of the California and U.S. constitutions, having prosecuted legal actions to enforce both to ensure governments treat men and women equally. For example, NCFM and two of its members have sued the Selective Service System to require the Selective Service System to extend to women the same right that men have to register for the U.S. Military draft, because the U.S. Department of Defense opened all combat positions to women in February of 2013. This case is pending in the United States District Court for the Southern District of Texas, Case Number 4:16-cv-03362, National Coalition for Men et al. v. Selective Service System et al.

NCFM respectfully asks, the City of San Diego and the County of San Diego to (1) postpone the upcoming San Diego Military Women (No Men) Careers Event (2) reschedule it (3) rename it something like "San Diego Military Women and Men Careers Event" or "San Diego Military Careers Event," and (4) invite, welcome, and accommodate "All Veterans," "All Active Duty," "All Spouses," and "WOMEN AND MEN IN THE GENERAL PUBLIC."
